WHEREAS, the breakdown of the herein considered MWD budget (in Philippine pesos) is as follows:

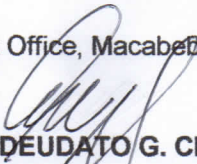

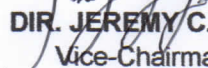
WHEREAS, the increase in budget for the year 2019 can be attributed to the following upgrades and expected expenses for the current year to wit (see attachments);

NOW THEREFORE, upon motion of the Board Chairman Adeudato G. Clarin, and duly seconded by the Board of Directors be it.

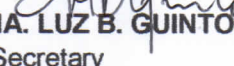
