We strictly follow the "No Lunch Break"
particularly the Public Assistance and Complaints Desk, did not comply with the No Noon Break policy.  The service office obtained a failed rating in the Physical/Layout and Basic Facilities sub-area due to lack of appropriate signages, comfort room and convenient waiting area.	Policy" as prescribed under RA 9485. Apart from adopting an appropriate working schedule, we assigned alternate personnel to ensure uninterrupted public service delivery.  • Directional signages for easy navigation in the office were posted.  • The management considered the renovation/construction of an office building in the 2017 Annual Budget to improve the office environment for clients' and employees' convenience.
The PACD signage was relatively small to catch clients' attention.	We made a bigger signage to foster the PACD's identification.
During the inspection period, it was observed that not all employees were wearing their IDs.	All employees, particularly the frontline service providers, were required to wear their nameplates/ARTA IDs for proper identification.
